

B. Tech Direct Second Year (Working Professional) Institute Level / Counselling Round Admissions for Academic Year 2025-26

Institute level Direct Counselling (Spot) Round for admissions to the Direct Second Year Engineering Programmes (B. Tech. Civil and Mechanical) for the Academic Year 2025-26 against the vacant seats after CAP-II Round of the Maharashtra State CET Cell for admission, will be conducted (as per the reference Rule No. 13 mentioned in the Information Brochure for the academic year 2025-26 published by State Common Entrance Test Cell, Maharashtra State) as per the details given.

Instructions:

- 1. Only the candidates registered online through CET portal and verified their application in scrutiny Centre or through E-Scrutiny, are eligible.
- 2. These admissions will be made strictly in the order of inter-se merit amongst the candidates who have applied through in the form available on the college website for counselling round at https://forms.gle/psYa5XiUuWVL1zmb6 this link and report in person for the counselling rounds on the date given above.
- 3. The candidate will need to pay online registration / application processing fee of Rs. 2,500/-.

- 4. The candidate will lose the claim to participate in the admission counselling process if he/she fails to produce all the applicable original documents at the time of document verification during the Counselling round. In case a candidate has taken admission elsewhere, he/she will be required to produce the original fees receipt, the Original Admission Confirmation Letter of that institute and submit one self-attested photo copy of each document.
- 5. After successful verification of the relevant original document, further eligible candidates will be called for seat allotment by counselling as per inter-se merit.
- 6. At the time of seat allotment by counselling, the candidate is required to submit "Requisition for Seat Allotment."
- 7. The seat allotment will be carried out based on the vacancy status at the time of candidates reporting to the counselling round (as per the reference Rule No. 13 mentioned in the Information Brochure for the academic year 2025-26 published by State Common Entrance Test Cell, Maharashtra State). Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats displayed on the auditorium screen. Candidates are advised to be present in the Counselling Hall and wait for their turn as per inter-se merit. If a candidate is not available when called, the next candidate on the merit list would be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment.
- 8. However, if a candidate of higher merit reports late during the process of counselling, and seeks admission against seats vacant (of a particular category to which he/she belongs) at the time of reporting, would get a preference for admission over the candidates with lower rank present at that point of time. The decision of the admission Centre in-charge shall be final and binding in this regard.
- 9. Confirmation of the allotted seat to the candidate is subject to the submission of the requisite documents & payment of Institute Admission fees. The candidate is required to pay fees through online mode or Demand Draft in favour of "Bharatiya Vidya Bhavan, SPCE" payable at Mumbai.
- 10. For Fee Details refer institute website.

Note: -

Government Resolutions published from time to time in this regard, will be applicable and bound to all the students.

- If a candidate fails to pay the requisite institute admission fees at the time of seat allotment, then his/her seat allotment will be cancelled and the seat will be allotted to the next candidate on the merit list. Part Payment or Payment through cash/cheque will not be accepted under any circumstances.
- Mere participation in the Counselling Round and paying the registration fees doesn't guarantee the confirmation of admission in the Institute.
- Candidate shall not be entitled to any refund of his/her fees except the Security Deposit / Caution Money Deposit if the online cancellation if effected by the candidate after 5.00 p.m. of the cut-off dated prescribed by the Competent Authority i.e., 03rd September, 2025.

Important Notice Regarding Courses for working Professionals (Direct Second Year Engineering)

As per the information brochure for AY 2025-26, Working Professionals provisionally admitted in a course of the institute where total admissions in a course are less than one third of approved intake of the course after pre cut-off date for admissions shall be transferred strictly on merit basis in the nearby institute within fifty kilo meters radial distance from the working industry or organization in the same course or different course in case vacancy exists in nearby institutes on the request of the candidate.

Process of transferring candidates from institutes having total admissions less than one third of approved intake of the course after pre cut-off date to the eligible institutes with above one third admissions of approved intake is as follows:-

4	Cut-off date for admissions to working professionals	15/09/2025 upto 5.00 PM

Important Instructions-

- 1. This process of transfer shall be carried out between pre cut-off date and cut-off date for admissions to working professionals.
- 2. Institute having admissions below 1/3 rd admissions after pre cut-off date has to refund full fees to the candidate in case of cancellation/transfer of admission immediately within two days of cancellation/transfer of admission.
- 3. Provisional Admission of the candidate shall be cancelled automatically if the candidate is not able to secure the admission on merit against vacancy in other institutes.
